*Enacted in 1972, Title IX is a federal law prohibiting sex-based discrimination. While initially aimed at the exclusion of women, it has expanded dramatically in both scope and complexity, and recent changes have significantly broadened its reach, strengthening protections for claimants, while placing exacting procedural requirements for the investigation and reporting of claims on schools. Ongoing legal challenges across the country have added further uncertainty, leaving institutions to comply amid shifting and sometimes conflicting guidance.*
